

CEO/Executive Director Transitions



- 13 transitions 6/13 women, 3 men of color, o women of color
- Women increased from 9 of 41(22%) to 10 (24%)
- Women of color stayed flat at 1 (2%)
- one Black
- Men of color increased from 2 (5%)
 to 4 (10%) two Black, two Latino

BOARD CHAIR TRANSITIONS 2019 – 2021

Board Chair Transitions



- 11 board transitions 7/11 women, 1
 man of color, o women of color
- Women increased from 17 of 50(34%) to 22 (44%)
- Women of color stayed flat at 3 (6%)
- one Asian, two Latina
- Men of color stayed status quo at 2
 (4%)

FINDINGS – THE GOOD AND THE BAD


- Progress for white women as board chairs 34% to 44%
- Progress for men of color as chief executives 5% to 10%

But...

No progress for women of color

MINIMAL GAINS FOR # OF BOARDS ACHIEVING PARITY

Female Representation on Boards



Board members – 18/50 boards (36%) have reached parity, slight increase from 16 (32%)

URGENT NEED FOR DATA TRANSPARENCY TO DRIVE PROGRESS

- Gender data (all positions) and limited race/ethnic data (Chief Executives, Board Chairs) came from Eos research.
- This bill calls for:
 - 1. Demographic data provided by all public board and commission **applicants** relative to ethnicity, race, gender identity and sexual orientation
 - 2. Demographic data provided by all public board and commission nominees or **appointees** relative to ethnicity, race, gender identity and sexual orientation;
 - 3. Any demographic data disclosed will be aggregated statistical data
